#### Refuse

At its February meeting, Keele Parish Council agreed to object in the strongest terms to the way that refuse is being collected at present in Keele. Refuse lorries are being parked some distance away from houses resulting in trails of rubbish. Also the plastic bags provided are not large enough to fit the dustbins. Bins at bus stops in the village are also not being emptied and consequently they are overflowing most of the time and rubbish is being redistributed around the village. Public spirited individuals have been emptying the bins themselves to ease the situation.

The Parish Council is also objecting strongly to Newcastle Borough Council's proposal to charge the University for refuse collection. In a letter to the Director of Housing and Health, the Parish Council sought reassurances that this charge would not include ratepayers from the Parish who live on the University campus, since University flat and house tenants who pay domestic rates are usually entitled to a refuse collection service. In response, the Borough Council pointed out that the litter collection in question would be from the halls of residence, which following recent litigation has now been deemed to be trade refuse for which a Council <u>must</u> make a charge. The separately rated domestic premises will continue to receive a free collection.

It was pointed out at the Parish Council meeting that if halls of residence were charged for refuse collection - the sum, quoted by the Borough Council was at first £27,000 and then reduced to £17,000, will be passed on to students in the form of an extra levy. The Chairman also stated that according to legal advice which he had received, the Council may make a charge and not must as stated in the letter from the Borough Council. Should this charge be insisted upon by the Borough Council, Keele University would be the only university in the country apart from Hull (involved in the litigation) to pay this charge and the Borough Council the only other council in the country to insist that it did.

The reason for this sudden insistence upon a charge for refuse collection should also be given. Is the Borough Council so desperate for funds that it needs to scour the statute books to discover where it may raise extra cash? In the 1985-86 Annual Report of the Borough Council, it was noted that Mayoral expenses for that year amounted to £27,000 and members' and other expenses amounted to £86,000. Perhaps these are areas where economies could be made by the Borough Council rather than making constituents pay for essential services. Perhaps, too, it is time that rate payers began to question more closely where their rates are being spent and to insist upon where this money should be spent.

"Already a review of local authority charges has been initiated. The Green Paper proposed that the scope of services for which Local Authorities charge should be widened and existing controls on charges be relaxed". (C.P.A.G. - A Tax on all the people: The Poll Tax)

## PARISH COUNCIL NEWS. . . .

## That Road

The County Council are being asked ways to improve the visibility for entry and exit to the University, since when the road improvements associated with the by-pass are effected, turning right to Newcastle out of the main entrance could be a problem. The improvement to the A525 between Gateside Corner (a well known accident black spot) and the main

entrance to the University had been suggested by the County Council. This would entail straightening the bend to improve sight lines. Some of the playing fields would have to be utilised. rebuilding of the university wall and the resiting of the memorial plaque and trees would be carefully monitored. The Parish Council has asked for a copy of the plans for the proposed 'A525 improvement scheme. The County Surveyor had informed the Council that £1.29 million had been made available for the work of the bypass and A525 improvements at Keele. The extra scheme would probably mean that work would begin in January 1989 rather than Autumn 1988 as planned.

## The Wall

The churchyard wall is nearing completion and extends right around the churchyard. It has definitely improved the look of the church surrounds and joggers and pedestrians can now use the pavement in safety. Parishioners have been delighted with the end product and Parish Councillors are so pleased that they are hoping to enter it for a civic award. Grateful thanks to all who helped with the rebuilding. It is hoped that the other walls in the parish will receive similar treatment.

That Seat




"Ee it's nice to have our seat back"

The wooden seat on the village green, damaged after an accident, is to be replaced by a new one by the Parish Council.


### Those Drains

The Borough Council had been informed that the new length of kerbing at Red Heath Plantation was ineffective and had increased flooding problems. Some Councillors were of the opinion that the land from which water was draining was the problem and that the landowner should be approached about it. It was generally felt that those affected by the flooding and debris at Red Heath Plantation and at the top of Pepper Street should consider asking for a rate rebate from the Borough Council, until the matter had been sorted out.

An estimate has been received and the Parish Council are in the process of asking residents of Highway Lane, those having access or using the lane to contribute towards the resurfacing.
