

Parish Meeting

The annual Parish Meeting was held on Tuesday, 19th April 1988. Twenty-two people attended the meeting. The Chairman reported on the past year's programme and discussed issues of importance that were due to be raised in the coming year, namely the resurfacing of Highway Lane and Keele as a conservation area.

It had been brought to the attention of the Parish Council that the surface of Highway Lane was deteriorating. It is ten years since it was last resurfaced. Whilst some residents and Parish Councillors living in Highway Lane thought it unfair for the Parish Council not to pay for the resurfacing thereby the cost would fall partly on individual householders, the Chairman thought it unfair to charge the whole parish, by means of a levy of the 2p rate, as had happened last time. Although the meeting was sedate, it was decided that there were three possible solutions to the problem: 1) The Highway Lane and Pump Bank residents should make a contribution to the resurfacing — the Parish Council had pledged to cover part of the cost already. 2) The Parish Council would in future charge residents an annual sum which would pay for the periodic resurfacing or 3) The surface should be allowed to deteriorate. A sub-committee was set up at a subsequent Parish Council meeting to decide upon the method of charging residents, and residents were

asked to submit any suggestions they may have to this end. The cost of the resurfacing had been estimated at around £4,000 and the Parish Council had resolved to contribute £1500 to these costs, the remainder being paid by the residents.

The reason for the controversy surrounding Highway Lane is that the Parish Council is the private owner of the lane, which is an unadopted road.

Delivery of mail was also discussed. It has now been decided that because of the confusion between departmental and private addresses, that residents of the campus living in the houses and flats should omit "Keele University" from their address forthwith. This has been agreed by the Keele Residents' Association and the Post Office has been notified and will take effect immediately.

PARISH COUNCIL NEWS

Praise

The Parish Council was delighted to see that after years of asking, the pavement from Church Bank to the A525 has been repaired. Likewise, the hedges along the pavement in Station Road have also been cut back allowing people to pass unscathed. At least two cheers for the Borough Council are in order here.

Churchyard Wall

The churchyard wall is all but complete and the Parish Council has entered it for the Civic Award Scheme 1988. Well done lads! The next area of improvement is to be the area around the war memorial which has been looking neglected for many years. There

will also be some landscaping work undertaken on 'the Green' in due course to compliment the new seat.

Wenslie Naylon, Co-ordinator of the 1988 Best Kept Village Competition, writes:-

WHY DON'T THEY?

Clear up the litter, cut the hedges, clip the grass, pull out the weeds ...
Probably because "they" 1) have Keele low on a long list of equally clamouring areas, 2) haven't the manpower any more, 3) don't think these things are as important as we might, who live here.

I'm not writing here about the rights and wrongs of standards of maintenance afforded to village communities by the Borough Council, but hope instead to put into context the Best Kept Village Competition and suggest that we in Keele might lose the habit, all too easy to acquire, of saying "...why don't they?..."

The Best Kept Village Competition is sponsored by the brewers, Bass Worthington and Mitchells and Butlers (West) and administered by the Community Council of Staffordshire. In their own words "it is not a competition about "pretty villages", its aim is "to encourage community spirit and stimulate pride in your village."

The judges will be in the village on two occasions between May and July and are looking for absence of litter and a generally cared for appearance in "public places" in the village — in our case this must mean around the school, University entrances, pub surrounds, the Post Office and telephones, Village Hall, Churchyard and war memorial.

A variety of initiatives are under way and we look forward to seeing the results of them; in the meantime, let's find some of that community spirit some of the villagers say no longer exists in Keele. It could be that when we see our public areas looking tatty and uncared for, instead of passing by and mourning the decline in standards we do something, that is YOU and ME, all of US in Keele.

Conference Centre

The Parish Council are to write to the University to ascertain the status of the wall in front of the Villa. The Parish Council were assured by the University that the wall would be reconstituted when building had been completed and that the wall would not be lowered.

Litter Bins

The Parish Council has requested two larger (than those provided) litter bins for the village. It is hoped that they will be used.

For Sale Signs

House for sale signs are appearing in the village which are nowhere near the house that is for sale. There is a law, apparently, which states that the sale sign should appear on the property it is advertising. When the estate agent was contacted he said this information was known, but as no-one enforced this law they would continue the present practice. The Parish Council contacted the Borough Council about the matter and were informed that there were too many other matters to deal with. The Parish Council are to pursue the matter.

Watch-the-Box

British Telecom have launched a 'Watch-the Box' payphone inspection scheme to try and improve the reliability of payphones, by inviting the local community to keep an eye on parish phone boxes. Drainage



"Given the drainage problems we have here, gentlemen, I think we'll need more than a few kerb stones to get rid of this lot."

The Borough Council are to lay more kerbing at Red Heath Plantation, Pepper Street, as they feel that the problem is caused by silt being washed from the hedge over the kerb by heavy lorries passing and thus blocking the drainage gulley. The Parish Council is not convinced that this is the cause and has requested that a grid be placed in the Hollywood area, to prevent water building up and running into the Red Heath Plantation area.

Village Hall

Final plans for the upgrading of amenities at the village hall have now been drawn up. Tenders were invited. However, as only two were received, it was decided to ask those firms to retender and to seek further tenders. In the meantime planning permission will be sought.

The next Parish Council meeting will be on Wednesday, 15th June 1988 at 7 pm in the village hall.
