#### 20/110 Covid – 19 – Community Response

1. Local Covid risks and responses

LC noted that the number of positive cases on and off campus stands at 53 which has reduced from 103. There are 175 isolating on and off campus. Noted that there is a disciplinary procedure for students that do not follow the rules. Students are asked to stay on campus and not access the village and other parts of the parish. Students off site have to record and track their movements. Track and trace codes are at all points in the university. Noted that a letter has been sent from Cllr Tagg regarding the current situation in the Borough.

Noted that there are number of bookings such as Taekwondo, rhythm time and hypnobirthing classes. Broadband was going to be £37 month, seems the installation with Openreach cannot continue until issues with the address not existing and no phone line in place. Noted they have reserves of £20k. Incentives for regular bookings are being made. Hearing loop is not working correctly which is being looked at.
- 5. Litter Picker report Dealings in the church car park, police to be requested to look at the bridge and car park. Time, date and registrations to be provided to GB. Defuncts signs and posts removed by County Council. No further burning at Hollywood and letter to be sent by Clerk if burning reoccurs. Noted that the car park needs managing by the owner to be included on the next agenda.

### **Parking**

No further information from Staffordshire about the progress of the TRO's. Parking pressure was significantly less this September. Nevertheless, despite the presence of available, legal parking spaces on Keele Road, drivers still manage to park adjacent to the double white lines.

# Neighbourhood Plan

We received a developing draft of the Dwsign Code work from AECOM which I have commented on. The document and my comments have been circulated to the Parish Council.

The Town Deal bid has been postponed to January and October and November's meetings cancelled. The next meeting is on 3<sup>rd</sup> December. There is a significant restructuring of proposals going on behind the scenes.

#### Yew Tree

I have prepared a 'bumper edition' of the Yew Tree. The draft is circulated with this report. It needs printing and delivering quickly as it contains information on Bonfire Night and Remembrance Sunday. I have asked residents to be considerate and avoid loud fireworks if they are planning a display. Remembrance Sunday cannot go ahead as a public event for obvious reasons. I am proposing a representative event with 6 people:

"The War Memorial belongs to the Parish Council and we have reluctantly decided not to hold such an event. Nevertheless, we judge it to be critical that our war dead are commemorated and intend to hold an outdoor commemoration at the War Memorial with six community representatives from the Armed Forces, Parish Council, Village Hall, WI, Scouts and the Church."

# Save Our Green Space

The Petition now has over 2000 signatures. The Facebook page has over 600 followers. Publications in the Sentinel which include comments from Stoke suggest that the draft of the JLP will not be published

before December and will be subject to full community consultation and not just a 'digital' consultation. We need to be vigilant for attempts to enter consultation over the Christmas period (this has happened before). I suspect that the COVID situation will delay consultation into the New Year and that the JLP may well need revising in the light of HMGov's planning reforms.

Duncan is making progress on his application for the Old Golf Course to be declared an asset of community value. A sub-group is being set up to examine the Council's arguments for building more houses in the Borough than the current housing formula suggests are necessary. SOGS plan to have posters printed on Correx board or similar to post around the site and request a donation from Keele Parish Council of £40.

### Hedges etc

Pepper Street hedge has now been cut. The hedge at the Quarry Bank lodge has not been cut as had been suggested. We will continue to ry and get a site visit from County Highways. A leaf sweep of areas of the village was conducted last week with a two-person team. One of the road from between parked cars. Unfortunately, the Borough note they cannot give us more than two days notification of sweeps to allow us to try and manage traffic, this is disappointing and I have asked the Clerk to politely push the matter.

The hedge on Quarry Bank remains uncut and we need to send a strong reminder that it needs doing as a matter of urgency.

# **Broadband Quarry Bank and Pepper Street**

We have received a complaint that the broadband on Quarry Bank and Pepper Street is slow and unreliable. The best connection speed seems to be around 9 mbps. The resident has undertaken to contact the local community to find out who their service providers are, what rate they have been promised and what actual speeds they are getting. Superfast Staffordshire show the area as 'Existing and planned commercial coverage'., i.e. they have no plans to get involved. I have asked the resident to use the Openreach fibre checker to see if fibre to premises is available.

# Village Hall

The decision has been taken to cancel the Christmas Party. The Village Hall team will decorate the outside of the hall. The usual Christmas Market at the Village Hall, in support of St John's Church cannot go ahead this year. Nevertheless, the traditional Keele Christmas card is available. It is £6 for 10 cards with envelopes or 65p per individual card and envelope Angela Studd will be happy to deliver packs of cards within a 3mile radius of Keele. All proceeds go to the church restoration fund. Its roof is badly in need of repair. If you would like cards, contact:

The Village Hall has been painted and looks great. WiFi will be installed on 3<sup>rd</sup> November, the monthly cost will be £37 a month. The committee wondered if KPC would like to contribute to the cost. I will be recommending that, for the present, we decline to do so.
