No further updates. I attended the Newcastle under Lyme Open Space and Green Infrastructure Strategy Workshop as did Tish, Tony and Wenslie. We left the consultants very clear about our concerns about the old Golf Course. Shawn Fleet (Chief Planning Officer0 of the Borough left us in doubt that the intended Options consultation in the Autumn would be presenting a housing plan for this land. Consultation on the Infrastructure Strategy will be expanded to the community in coming weeks. I have asked that the Borough liaise with Parish Councils to ensure that 'hard to reach' residents are involved.

The business of getting the Broadband installed is moving forward. BT have agreed to pay half the costs for a pole to be installed i=on Village Hall land but Diane continues to liaise with the Ombudsman about how BT's contribution will be received.

## The Great Stench

No doubt you will be aware that our MP raised in P.M's question time and the P.M expressed frustration with the rate of progress. A court action is being taken by Stop the Stink against the EA, it will be held on 23<sup>rd</sup> July by video link.

The current update on the Environment Agency website contains the following information:

• For the week 4 July to 11 July, hydrogen sulphide levels were below the World Health Organisation's (WHO) 24-hour average health guideline level to protect against short-term health effects but were above the WHO 30-minute average odour annoyance guideline level between 3% and 17% of the week. During this week we received 853 odour reports from local people.

## **Hedge and Veg sub-committee**

Wenslie and I did a Hedge and Veg walk on Saturday and made the following notes:

**For discussion:** we view Keele is a rural parish and due consideration needs to be given to protecting species diversity and providing habitats for plants and animals. We do not believe it is possible or desirable to ask the land users to cut hedges and verges more than once a year. Ideally this cut should be at the end of nesting season (August). This should ensure that path obstruction is minimised during the following season. Where footpaths become dangerous because of outgrowth, this will be dealt with on a caseby-case basis. What can be achieved is a necessary compromise between desirability, cost and achievability.

The epicormic growth from the Limes fronting the Hawthorns is obstructing the footway and needs cutting back. I have written to Seddon to request.

Station Road is passable, the occasional briar needs cutting back

Pepper Street towards the A525 is dangerous and obstructed. The owner has been contacted and is arranging a cut. We need to discuss the best way of managing this narrow, dangerous footway in future.

Pepper Street towards Silverdale id obstructed in places. The clerk will write to the tenants asking that they cut asap.

Several houses on the side of The Village ops. Hawthorns have hedges that have crept out into the narrow footway. We will write to them in due course asking that they cut back to the inner edge of the footway.

Litter collector will remove briars at the top of Three Mile Lane (Keele Farmhouse)

Three Mile Lane has heavy verge vegetation but can be cut at the end of the summer.

Quarry Bank Road passable along its entire length. As always, the main impediment to wheeled vehicles on Quarry Bank are vehicles. End of summer cut. Whilst Quarry Bank Roads footpath is obscured by outgrowth form the hedge and verge, the road provides a safe walking route. I will discuss the woodland in the approach to the bridge from Quarry Bank with County. It is obviously managed to some degree.

Golf Course Club House hedge. End of summer cut, verge provides safe passage.

Corner of Keele Road and A525 by memorial plaque, footway obstructed. I will discuss with County at our site meeting on Wednesday 21<sup>st</sup> July as I think they may be the owners.

Keele Road has dense vegetation from the verge but is broadly passable, end of summer cut. We met a gentleman taking hay from the old cricket ground field and may now have a valid phone number for the owner.

Outgrowth from the church yard is obscuring the footpath along Keele Road where it fronts the Village. Keele Conservation Group are no longer managing the wild areas of the church yard. The clerk will be asked to contact the PCC (Steve Mellor).

## **Gullies**

Following a complaint from a resident regarding the gully under the bridge on the A525, Highways have now done a 'gully suck'. I have also been told other gullies the A525 are block which I will investigate in due course.

I have a site meeting with County Highways Community liaison on Wednesday 21st July when I will be discussing the gully at 2, Station Road amongst other issues.
