The major issue here is the lay by/bus stop that SCC are insisting is removed and we are being passed from pillar to post at County. I have written to Simon Tagg (his first task as our new County Councillor) and am awaiting a response. I will chase this later this week.

# **Environment & Assets Report May 2025**

Date

The Yew Tree in the centre of the village is still looking very unhealthy and we are waiting for the Borough Council to respond to a request for composted bark. In the meantime, the irrigation will be turned on again for six weeks, and we will monitor progress.

There is still an issue with the width of the A525 footpath as you approach the University roundabout. It is too narrow for mobility scooters and it is dangerous for them to use the busy A525 at this point. We are pursuing this with both Borough and County councils.

There remains an issue of overgrowth of tree/shrub branches on the footpath along Keele Road. As this is where cars are usually parked, once again a mobility scooter would have to descend into the road for quite a stretch.

The footpath down Three Mile Lane to Keele Services is unusable due to flooding. This has been reported to Severn Trent Water.

Although we are now in nesting season hedges that are alongside pavements can be cut back carefully to prevent pedestrians being forced into the road. With the increased number of buses are travelling through the Village due the new K service it is important that footpaths are kept clear.

Unfortunately, there have been another couple of fly tipping incidents, but these were reported by our litter picker and have been cleared.

# Planning Report for Keele Parish Council May 2025

# **Borough Plan**

The formal inspection of the borough plan will take place over three weeks at the end of May and the beginning of June. Submissions to the Inspector were invited and Keele Parish Council made a submission covering aspects of the planned house building in areas surrounding Keele, the University's plans for expansion and aspects of highways development. I have circulated the comments with this updated report.

In brief, KPC recognise that if the current plan is rejected then any new plan will need to include much higher targets for house building. Thus, we broadly support the plan and welcome the inclusion of a Country Park in the Golf Course development. Nevertheless, we raised concern on a number of points of detail. We would hope the outcome of the Inspection would be hat the Borough were required to offer further clarification on these points.

# **April**

25/00218/PIP Application for permission in principle for the erection of a detached dwelling. Land Between Station Road and the A525 Keele Newcastle-under-Lyme Staffordshire. Pending. This is an application to for permission in principle to build up to three houses on the 'teardrop' of land on the left-hand side of the junction of Station Road and the A525. This land is currently in use for growing Christmas trees. I recommend we object. This land is Green Belt and outside the village envelope which would allow 'infill.' The application notes the recent changes to legislation concerning Green Belt development. This land is not grey belt; building would impact on openness of the greenbelt and would constitute a dangerous precedent for building on other green spaces in Keele. I believe we should object.

25/00217/PIP Application for permission in principle for the erection of a detached dwelling |. Land Adjoining 54 Station Road Keele Newcastle Under Lyme Staffordshire. Pending. This is the return of an old application which has been refused in the past on the basis that the land concerned lies outside the village envelope and thus, that policies concerning infill do not apply. The justification quotes the new planning policies concerning greenbelt development as the reason for resubmission. We have not objected to the proposal in the past and I do not think we should do so this time. The permission would not create a precedent as the site would 'complete' row of houses and could be considered valis infill. **Decision is to permit.** 

<u>25/00278/PLDLB</u> | Application for certificate of lawfulness of proposed works to a listed building - replacement of the existing internal fire alarm system | The Chapel Keele University Three Mile Lane Keele Newcastle Under Lyme Staffordshire. **Decision is to permit.** 

25/00246/PLD | Application for a certificate of lawfulness for a proposed single storey extension to side | Rockside Leycett Lane Leycett Newcastle Under Lyme Staffordshire ST5 6AL. Permitted.

Consultation on an application for a Public Path Extinguishment Order and a Public Path Creation Order to run concurrently. Keele Footpath No.6 (part). Nearest Post Code: ST5 6AB. Grid Reference: 379335 346266. Pending. This is a proposal move the footpath which cuts behind 'Upper Farm' where development is underway. I see no justification for this proposed closure nor the proposed new path. Reviewing the original email on this matter, it is not clear if and where any application for extinguishing the path has been made. I will investigate further.

**REF. NO. SCC/25/0035/MDPO** Application to Modify a planning obligation to amend Schedule 3 of the Section 106 Agreement in relation to planning permission N.02/17/258 MW to remove the restriction on the supply of Etruria Marl from Keele Quarry. Deadline for comments passed. This is a technical application, if approved it would result in marl which is not currently in use being taken to Tunstead near Buxton for cement manufacture. It will result in an increase in heavy vehicles on the A525. I am content to leave this matter to officers. **Status Preparing a decision - report / letter / notice.** 



**Footpath from Quarry Bank to Silverdale.** We have been reminded that the Secretary of State's direction to County to address this long-standing matter has a deadline of 17<sup>th</sup> May. I propose the Clerk writes to County to remind them that we await a prompt decision from them. The County have responded noting:

... I note that the Inspectorate has directed that this matter is determined by 17<sup>th</sup> May 2025.

The Council has received many Directions from the Planning Inspectorate and our team are working through these Directions as a priority. There are no repercussions for not determining within the time directed by the Inspectorate although we respect their authority and endeavour to follow their mandates as closely as our staffing and resources allow.

This application is the next application on the team's list, which has been delegated to me. I therefore hope to be able to start work on the matter within the next three or four weeks.
