## **MINUTES OF KEELE PARISH COUNCIL REGULAR MEETING**

### **147/25 To receive apologies**

Apologies were received from County Councillor S Tagg (ST), Mr T Arnold (TA). The Meeting noted the resignation of Ms C Cox.

### **149/25 Public Open Forum.**

The Meeting welcomed Keele University's Vice Chancellor Professor Kevin Shakesheff who updated the Meeting on the student numbers, the financial position and plans for developments at the University. GB thanked the new Vice-Chancellor for attending the Meeting.

## 5. Chair's Report and Planning: November 2025

### Chair's remarks

The modifications to the Borough Plan following the comments from the Inspector are now open for public consultation. Until the plan is approved, its proposals have limited weight in deciding planning applications. What this means is that the Borough is very poorly protected from developers who can argue that it cannot meet its House Need targets. As a result, proposals for development, even in the Green Belt, are likely to be approved. Unfortunately, even if the pending plan is approved by the Inspector, following modification, it will still not provide sufficient houses to meet this Government's new targets. It will provide a much greater degree of protection from speculative development, but the Borough will immediately need to begin a new plan with significantly higher housing targets.

The situation is further complicated by Local Government reform which is leading towards all local government being delivered by unitary authorities in the new couple of years. This would mean that Newcastle Borough is likely to cease to exist before any new Borough Plan could be put in place. The nature of the authority that would replace it has yet to be determined.

Keele Parish Council will be replying to the consultation on the modifications to the Local Plan before the deadline of 17<sup>th</sup> December. We remain in favour of the plan being adopted as soon as is possible but will consider the proposed modifications carefully in the light of the Inspectors original comments.

Given the pressure on us regarding speculative applications to develop green belt land and the liberal interpretation of the concept of grey belt being taken by the local planning authority, our Neighbourhood Plan will be critical in providing Keele Parish with a degree of extra protection. We are due to approve the consultation materials at our meeting on Monday 10<sup>th</sup> November and the regulation 14 consultation will start on the 20<sup>th</sup> November and run until 15<sup>th</sup> January. We will need to get individual mailings through doors at pace and I propose we use the same distribution volunteers employed for the Yew Tree.

In further news, we have yet to hear back from Seddon regarding the Management Company at the Hawthorns. You will remember that the current state of play is that the management contractors, Trinity, have noted they are awaiting instructions from Seddon to poll residents regarding volunteers for a residents' led company.

There is still no contact from County Highways concerning the pull-in on Pepper Street and our proposal it be plough shared into a bus stop. We need to consider escalating our attempts to get a response from David Greatbatch of County Highways. Our meeting at the Oakes in October confirmed that Seddon have no immediate plans to remove the layby but will have to do so before the site is signed off.

I have made posts of the Facebook site over the last month, linking to the bulletin, offering advice on Halloween and Bonfire Night, promoting the consultation on the Borough Plan and linking to smart alerts. We need to look at putting together a program of releases for each month.

Finally, the Parish Council was represented at the well-attended All Souls service on Sunday 2<sup>nd</sup> November where members of the congregation and others had an opportunity to light a candle for the departed. The heating is not currently working in the church, but a repair is due in the next month so that the Church will be warm for Christmas services. The Remembrance event will be held on Sunday 9<sup>th</sup> at 10:45 at the war memorial where a wreath will be laid by Keele Parish Council. All Councillors are invited to attend. The event has been publicised through the bulleting list, notice boards and on Facebook.

### **Other planning matters:**

**Boggs Cottages:** we are working with residents and with our Borough Councillor to obtain clarity on the status of the permission to occupy the site granted at appeal nearly two years ago. Key conditions have not been satisfied by the owner and the original building has been demolished. We recognise that the owner of the site may seek new permission for development of the site and the LPA's current interpretation of what counts as 'grey belt' gives cause for concern.

*Both of these applications use similar arguments to those used in the recently permitted application for 6-9 houses on land south of Pepper Street. The essence of the argument hinges on the absence of a made Borough Plan and the fact that the plan under examination does not provide sufficient houses to meet the target set by the current algorithm. I recommend we object, these are dangerous precedents.*

Application for permission in principle for the erection of 6 to 9 dwellings, Land South Of Pepper Street Keele Newcastle Under Lyme Staffordshire

Unfortunately, our objections and those of Borough Councillor Dave Jones were given no weight. Officers had written strongly recommending the application be permitted, basing their arguments on those made in the application. It would seem that the fact that the Borough Plan had yet to be 'made' meant that it only had moderate weight in this matter. Until a Borough Plan and Neighbourhood Plan are in place, it would seem any application to build less than 10 homes in the green belt is likely to be accepted.

## April

REF. NO. SCC/25/0035/MDPO Application to Modify a planning obligation to amend Schedule 3 of the Section 106 Agreement in relation to planning permission N.02/17/258 MW to remove the restriction on the supply of Etruria Marl from Keele Quarry. Deadline for comments passed. This is a technical application, if approved it would result in marl which is not currently in use being taken to Tunstead near Buxton for cement manufacture. It will result in an increase in heavy vehicles on the A525. I am content to leave this matter to officers. **Status currently awaiting more information from the applicant to address matters that have been raised during the consultation process. Highways have requested further information on traffic movements.**
